# Registrant Disclosure of Interest Acquisition of Property

## Form 160

for use in the Province of Ontario

*GENERAL USE: This form contains the mandatory disclosure required in order to comply with the provisions of the Real Estate and Business Brokers Act and Code of Ethics for a registrant who is involved in the purchase of a property.*

*The bold statement at the beginning confirms that the information contained in this form addresses the requirements of the Real Estate and Business Brokers Act and Code of Ethics.*

**This statement is made in accordance with the requirements of the Real Estate and Business Brokers Act and Code of Ethics Regulations of the Province of Ontario.**

*The information begins with the name of the registrant, their designation (whether salesperson, brokerage, or broker) and the name of the brokerage. It continues to identify the property that is the subject of the transaction.*
