This statement is made in accordance with the requirements of the Real Estate and Business Brokers Act and Code of Ethics **Regulations of the Province of Ontario.**

The information begins with the name of the registrant, their designation (whether salesperson, brokerage, or broker) and the name of the brokerage. It continues to identify the property which is the subject of the transaction.
