GENERAL USE: In order to comply with the requirements of the Real Estate and Business Brokers Act, 2002 (REBBA) and to ensure that information that would otherwise be considered private is available for a REALTOR® to use in their advertising this Consent to Advertise Form would provide the necessary permission to advertise information.

The introduction to the Form in bold type highlights the purpose of the Form. Consent is needed before information from a real estate transaction is used by a REALTOR® in their advertising to comply with legislation.

The Brokerage including their representatives are required to comply with the REBBA 2002 and other legislation where there are provisions to obtain consent before identifying certain information related to a transaction.
