# Entry/Access to Property Seller Acknowledgement

*GENERAL USE: This form is essentially a permission form for the Seller to consider and sign. It sets out the appropriate consent for a Brokerage, sales representative or broker when there will be individuals who attend the property for purposes such as home inspection or appraisal.*
