# Amendment to Agreement of Purchase and Sale - Commercial

*GENERAL USE: This form is used when the parties to an Agreement of Purchase and Sale wish to make one or more alterations to the agreement.*

*IDENTIFICATION OF PARTIES: The parties to the original agreement are set out here because it is those parties who have the ability to make any changes to the original agreement.*

*IDENTIFICATION OF THE AGREEMENT: The Agreement of Purchase and Sale, that is going to be subject of any change, is identified by its date and the description of the property.*

*AMENDMENT DETAILS: This area of the form is where changes to the original agreement are described and introduced in two sections. **DEFINITIONS:** The form contains a number of definitions to reflect certain words, such as, Buyer includes purchaser.

For the purposes of this Amendment to Agreement, "Buyer" includes purchaser and "Seller" includes vendor.

**TIME IS OF THE ESSENCE:** Time is important for taking action or completing any matter, the parties are held to a strict time standard.

Time shall in all respects be of the essence hereof provided that the time for doing or completing of any matter provided for herein may be extended or abridged by an agreement in writing signed by Seller and Buyer or by their respective solicitors who are hereby expressly appointed in this regard.

**REMAINING TERMS:** Except for any changes noted in this Amendment the original Agreement is considered to be the same in all of its provisions. The Amendment form is effective when all the parties have agreed within the specified time frame. If spousal consent is necessary, then there is a place for the spouse to sign consenting to the changes.

**All other Terms and Conditions in the aforementioned Agreement to remain the same.**
